

## SPRING 2024 UNDERGRADUATE ACADEMIC ADVISEMENT

All Annenberg majors graduating in fall 2024 or later have an advisement requirement.  
You must meet with an advisor to register for spring 2024 classes.

Advisement is not required for minors. Class standing is based on the number of units **COMPLETED** and does not include current classes. **The Schedule of Classes and your registration time will be available on myUSC on October 2.**

**Fall 2023, Spring 2024, and Summer 2024 Graduates and ALL SENIOR students:** You are **NOT** required to meet with your advisor. You will receive an updated Course Plan from your academic advisor with your schedule and important information. If you'd like to meet with an advisor, please attend any Virtual Drop-In day.

**Appointment Schedule:** Students with both major and minor within Annenberg (e.g., COMM Major and JOUR Minor or JOUR Major and COMM Minor) can schedule **one appointment**. No appointments during Fall Break (**Oct 12-13**).

**Scheduling an appointment:** Students will schedule their advisement appointment online. A link to schedule your advisement appointment will be sent to your USC email account on the first day you can schedule your appointment, based on class standing.

**Appointment Policy:** You will be able to schedule one appointment. If you can no longer attend your appointment, reschedule using the same link. Reschedule at least 24 hours in advance. If not, attend a Virtual Drop-In day. If you are late by 10 minutes, missed your appointment, or canceled less than 24 hours in advance, you must attend the next available Virtual Drop-In.

**Virtual Drop-In Advising:** Starting October 4, Virtual drop-in advising on Wednesday and Friday from 10a – 12p during Mandatory Advisement period. Availability with your advisor on Virtual Drop-In days not guaranteed. No Drop-In Advising during Fall Break (Oct 12-13).

**Missed Appointment:** If you missed your advisement appointment or want to meet with your advisor again, you can attend a Virtual Drop-In or schedule an appointment for **October 30** or later. Annenberg students can schedule via mandatory advisement appointment link.

**Non-Major Information:** All non-majors must complete an online form to request D-clearance for a JOUR or PR class. This form will be available online after Mandatory Advising. If you want to apply to an Annenberg major or minor, please attend an upcoming information session (<http://annenberg.usc.edu/nonmajor>).
