

FALL 2024 UNDERGRADUATE ACADEMIC ADVISEMENT

All Annenberg majors graduating in fall 2025 or later have an advisement requirement. You must meet with an advisor to register for fall 2024 classes.

Mandatory Advisement (MA) appointments are scheduled based on class standing, which reflects the number of units **COMPLETED** and does not include current enrollment. The Schedule of Classes and your registration time will be available on myUSC on March 4.

Students graduating in Spring 2024, Summer 2024, Fall 2024 or Spring 2025: You are **NOT** required to meet with your advisor. You will receive an updated course plan via Advise USC and your MA Hold will be lifted. If you would like to meet with an advisor, please attend any Virtual Drop-In day.

Scheduling an appointment: A link to schedule your advisement appointment online will be sent to your USC email account on the first day you can schedule your appointment, based on class standing.

Appointment Policy: You will be able to schedule one appointment. If you cannot make your meeting, please reschedule via the link at least 24 hours before. If you are late by 10 minutes, miss your appointment, or cancel with less than 24-hour notice, you may schedule one more appointment during the Mandatory Advising period. If you miss that appointment as well, you will be required to wait until after March 29 to re-schedule.

Virtual Drop-In Advising: Every Wednesday from February 28 to March 27 from 10am-12pm and 1:30-3:30pm (except Spring Break), there will be virtual drop-in advising to answer follow-up questions (not to meet the mandatory advisement requirement). You must sign up 30 minutes prior to drop-ins concluding (11:30am & 3pm).

Non-Major Information: Non-majors can meet with Annenberg advisors from April 8 – April 19. During that time frame, you may email the general email to schedule an appointment.
