SPRING 2025 UNDERGRADUATE ACADEMIC ADVISEMENT

All recently admitted Annenberg majors (including summer freshman & transfer admits and summer/fall change of majors) have an advisement requirement, as well as those students on academic probation. You MUST meet with an advisor before you can register for Spring 2025 classes.

Pre-Registration Advisement appointments are scheduled based on class standing, which reflects the number of units **COMPLETED** and does not include current enrollment. The Schedule of Classes and your registration time will be available on myUSC on October 7.

Continuing USC Annenberg students (not on probation): You are **NOT** required to meet with your advisor. You will receive an updated course plan via Advise USC and your MA Hold will be lifted. If you would like to meet with an advisor, please attend any Virtual Drop-In day. You may also schedule an advising appointment during your class standing.

<u>Scheduling an appointment</u>: A link to schedule your advisement appointment online will be sent to your USC email account on the first day you can schedule your appointment, based on class standing.

<u>Appointment Policy</u>: You will be able to schedule one appointment. If you cannot make your meeting, please reschedule via the link at least 24 hours prior. If you are late by 10 minutes, miss your appointment, or cancel with less than 24-hour notice, you may schedule one more appointment during the Mandatory Advising period. If you miss that appointment as well, you will be required to wait until after November 7 to re-schedule.

<u>Virtual Drop-In Advising</u>: Every Wednesday from October 9 to November 6 from 10am-12pm, there will be virtual drop-in advising to answer follow-up questions (NOT to meet the mandatory advisement requirement). You must sign-in to the meeting and spreadsheet 30 minutes prior to drop-ins concluding (11:30am).

Non-Major Information: Non-majors can meet with Annenberg advisors from November 9 – November 26. Please create a referral in Advise USC to the program of your interest, and mark yourself as "Ready for Advising." At that point, you will be assigned a referral advisor to whom you can reach out with your questions.
