

## **SPRING 2023 JOUR/PR D-CLEARANCE PROCESS**

## JOUR AND PR COURSE NUMBERS WITH A "D" REQUIRE STUDENTS TO OBTAIN DEPARTMENT APPROVAL BEFORE REGISTRATION.

Majors, Minors and Non-Major students will receive access to the online JOUR/PR D-Clearance Request Form on the following dates. Any submissions received before the appropriate date will not be processed. If a class is not listed on the d-clearance form, it will not require d-clearance.

| JOUR/PR Major - Senior    | October 12                       | October 19                          |
| JOUR/PR Major - Junior    | October 19                       | October 21                          |
| JOUR/PR Major - Sophomore | October 26                       | October 28                          |
| JOUR/PR Major - Freshmen  | November 2                       | November 4                          |
| Annenberg Minors          | November 9                       | November 11                         |
| Non-Major                 | November 15                      | Early January                       |

**D-Clearance Process**: A link to request d-clearance will be sent to your USC email account on the first day you can submit d-clearance requests, based on class standing. D-clearances will be issued based on program, class standing and graduation date first, and then on a first come, first serve basis. Submitting a D-clearance request does not issue d-clearance, nor does it guarantee that you will receive d-clearances for your first choice.

<u>Confirmation</u>: Please check online on Web Registration > My Info > Cleared Sections for your d-clearance every Wednesday and Friday, after the first processing day listed above.

**Expiration:** All D-Clearances will **EXPIRE** on **November 23**. If you have a **HOLD** on your account and need an extension, please contact your advisor as soon as possible.

**<u>Registration</u>**: If you receive clearance, **you are responsible** for registering for the course on Web Registration. Annenberg Advisement cannot add or drop courses for you.

<u>Change Requests:</u> If you are cleared for a section, you **must register** for your cleared section to **guarantee a** seat in the course. Please **do not** submit **another** request **before** <u>November 23</u>, as it will not be processed. If you need d-clearance for another section, you may submit another request <u>after</u> d-clearances expire on <u>November 23</u>.
